Public Notice is further given that the agenda was posted on the Courthouse Bulletin Board on Tuesday, June 2nd 2026, at 2:30 P.M. on the upper and lower west doors. Additionally, the required public notice time frame is exclusive to any day on which the Courthouse is closed, such as holidays, or weekends falling within 72 hours in advance of regular or special meetings of the Court.

Public Matters which were placed on this Agenda at least 72 hours prior to this meeting of the Court, which may receive both consideration and action by the Court as follows:

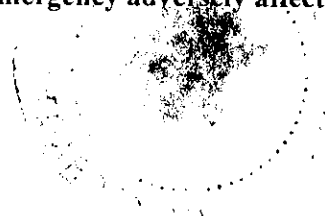

- J. Discuss and take action if necessary on approving the Declaration of Disaster regarding the threat of new world screwworm
- K. Review and approve all bills and payroll for the road hands and the courthouse employees.
- L. Other Items of discussion.

II. Pursuant to the authority granted under the Government Code, Chap. 551, the Commissioner's court may convene a closed session to discuss any of the above agenda items. Immediately before any closed session the specific section or sections of Government Code, Chap. 551, that provides statutory authority will be announced.



The agenda and its required advance public notice are governed by the Texas Open Meetings Act which requires that the agenda be posted upon the Courthouse Bulletin Board at least 72 hours prior to regular and special meetings of the Court and 2 hours prior to emergency meetings in which an unforeseen emergency adversely affects public safety, public services or public property.
