(A) Minutes from the previous meeting were reviewed, Motion to accept was made by Commissioner Haynie and seconded by Commissioner Tamplen, with all in favor. **Motion Carried.**

(B) No comments on the day's agenda from the public. **No Action Taken.**

(C) TX DOT representative Wesley Kajs, reported that the State has been busy doing some Blade Patching. Also, as agreed between the State and County, they will be unloading 4,000 cubic yards of RAP at the County Barn. **No Action Taken.**

(D) TDEM representative was absent. **No Action Taken.**

(E) Foard County Sheriff Shaw then gave a report of his office. Deputy Madwell has been doing very well and has received many compliments. The conference he just attended went well and had some useful information. He also stated he would like for the County to apply for a credit card just for his office. Perry will get more information about the credit card and update the commissioners on his findings. **No Action Taken.**

(F) After brief discussion the Commissioners agreed to reappoint Paul Wylie as the Board of Directors for the Nortex Housing Finance Corporation. Motion to accept was made by Commissioner Wisdom and seconded by Commissioner Johnson, with all in favor. **Motion Carried.**

(G) Treasurers June 2025 report was then reviewed. Motion to accept was made by Commissioner Tamplen and seconded by Commissioner Johnson, with all in favor. **Motion Carried.**

(H) Commissioners then discussed the purchase of a Trac Hoe and Thumb. Commissioners agreed to make the purchase with a contingency price of \$200,000 for the Trac Hoe and \$9,000.00 estimated price of the Thumb. Judge Christopher will discuss with the representative the details. Motion to accept was made by Commissioner Haynie and seconded by Commissioner Wisdom, with all in favor. **Motion Carried.**

(I) Monthly bills and payroll for all employees were then reviewed. Motion to accept was made by Commissioner Wisdom and seconded by Commissioner Haynie, with all in favor. **Motion Carried.**

(J) No other items of discussion. **No Action Taken.**

(K) With no other items of discussion motion to adjourn was made by Commissioner Haynie and seconded by Commissioner Johnson, with all in favor. **Motion carried.**
